Pursuant to the provisions of Section 617, Florida Statutes, this Florida corporation, not for profit adopts the following amendment to its Articles of Incorporation:

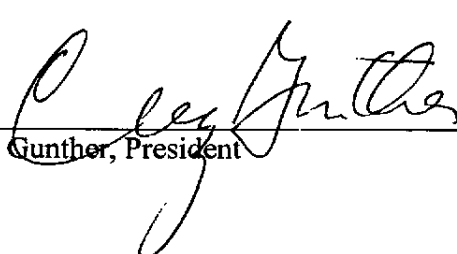
- FIRST:** The date of filing of Articles of Incorporation was **June 16, 2005**
