**Article 1**

The name of the corporation is Faithful Few Missionary Baptist Church, Inc.

**Article 2.**

The principal place of business and mailing address of the corporation is 1771 West Edgewood Avenue Suite #6, Jacksonville, Florida 32209.

**Article 3.**

The specific purpose(s) for which the corporation is organized are:

The purpose of which the organization call Faithful Few Missionary Baptist Church, Inc. is organized are exclusively religious, charitable, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law.

**Article 6.**


