ARTICLES OF INCORPORATION FOR MIAMI LAKES TOWN FOUNDATION, INC., a Florida not for profit corporation

The undersigned, pursuant to Chapter 617 of the Florida Statutes, hereby submits the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be MIAMI LAKES TOWN FOUNDATION, INC. (hereinafter referred to as "Corporation").

ARTICLE II

The principal office address and mailing address of the Corporation is: 6853 Main Street, Miami Lakes, Florida 33014.

ARTICLE III

- 1. No Stock. The Corporation is organized upon a non-stock basis.
- 2. No Members. The Corporation shall not have any members.

ARTICLE IV

The Corporation shall have perpetual existence.

ARTICLE V

The Corporation is organized and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. In furtherance of such purposes, the Corporation shall be authorized:

- 1. To encourage, foster and conduct programs for the continuing education and literacy education of members of the community, including, but not limited to, the imagination Library Program.
- 2. To conduct and develop other programs within the community related to youth projects, beautification projects, and other cultural events for the benefit of the community and its citizens.
- To solicit and accept contributions of money and property and to accept devises and bequests and all other monies and property made available by virtue of trusts,

endowments, deeds of gift, annuities, policies of insurance, or otherwise, and to use, administer, invest, grant, expend, sell, lesse, convey and dispose of any of its monies or property and invest or reinvest any proceeds therefron, for the furtherance of the Corporation's purposes.

To do all acts and things requisite, necessary, proper, and desirable to carry out and further the objects for which this Corporation is formed; and, in general, to have all rights, privileges, and immenities, and enjoy all the benefits of the laws of the State of Florida applicable to corporations of this character, including, but not limited to, the powers described in Section 617.0302 of the Florida Statutes, subject however to the requirements of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and to the other limitations provided in these Articles of Incorporation.

ARTICLE VI

The street address of the Corporation's registered office is: 6853 Main Street, Miami Lakes, Florida 33014. The name of the Corporation's registered agent at this office is: Alex Roy.

ARTICLE VII

The number of directors may be changed, from time to time, in accordance with the Bylaws, provided that there shall at all times be at least three (3) directors. The names and addresses of the porsons who shall serve as the initial board of directors until the first annual meeting of the directors or until their successors are elected and qualified are as follows:

The method of election of directors and their term of office shall be in accordance with the Bylaws.

ARTICLE VIII

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered

and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation (i) exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section 170(c)(2) of the Internal Revenue code of 1986, or the corresponding section of any future federal tax code; or (ii) contributions to which are deductible under Section 170(c)(2) of the Internal Revenue code of 1986, or the corresponding section of any future federal tax code.

ARTICLE IX

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or shall be distributed to the Town of Miami Lakes, a Florida municipal corporation, for the general purposes for which the Corporation was organized, or another organization operated exclusively for charitable purposes and which qualifies as tax exampt under the Internal Revenue Code of 1986, as amended; provided that the assets so distributed will be subject to the conditions, restrictions, and limitations to which such assets were subject to when they were assets of the Corporation.

ARTICLE X

To the maximum extent permitted by Florida law, the Corporation shall:

- Indemnify any person who was or is a party to any proceeding (other than an action by, or in the right of the Corporation), by reason of the fact that he or she is or was a director, officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise against liability incurred in connection with such proceeding, including any appeal thereof, if he or she acted in good faith and in a manner he or she reasonably believed to be in, or not opposed to, the best interests of the Corporation and, with respect to any criminal action or proceeding, had no reasonable cause to believe his or her conduct was unlawful. The termination of any proceeding by judgment, endow, actionest, or sometime us upon a place of sula contenders or its equivalent shall not, of itself, create a presumption that a person did not act in good faith and in a manner which he or she reasonably believed to be in, or not opposed to, the best interests of the Corporation or, with respect to any criminal action or proceeding, had reasonable cause to believe that his or her conduct was unlawful.
- 2. Indemnify any person who was or is a party to any proceeding by or in the tight of the Corporation to produce a judgment in its favor by reason of the fact that he or she is or was a director, officer, employee or agent of the Corporation or is or was serving at the request of the Corporation as a director, officer, employee or agent of another

corporation, parmership, joint venture, trust or other enterprise against expenses and amounts paid in settlement not exceeding, in the judgment of the board of directors, the estimated expense of litigating the proceeding to conclusion, actually and reasonable incurred in connection with the defense or actulement of such proceeding, including any appeal thereof.

Expenses incurred by an officer or director in defending a civil or criminal preceding shall be paid by the Corporation in advance of the final disposition of such preceding upon receipt of an undertaking by or on behalf of such director or officer to repay such amount if he or she is ultimately found not to be emitted to indomnification by the Corporation.

The indemnification and advancement of expenses provided pursuant to this Article are not exclusive, and the Corporation may make any other or further indemnification or advancement of expenses of any of its directors, officers, employees, or agents, under any Bylaw, agreement, vote of disinterested director, or otherwise both as to action in his or her official capacity and as to action in another capacity while holding such office.
