

Amendment 1: Doctrinal Statement: Amend Article III Section 1, including scripture to doctrinal statement. We believe that all scripture (Old and New Testament) is given by the inspiration of God and is the supreme and final authority of the Church (2 Tim. 3:16).

Amendment 2 Marriage/Sexuality: Amend Article III, including a clear definition of marriage according to scripture Matthew 19:4-5. We believe in the sanctity of marriage which has been established by God as a lifelong, exclusive relationship between one man and one woman and that all intimate sexual activity outside of the marriage relationship, whether heterosexual, homosexual or otherwise including all identifying with the LBGQT community

is immoral and therefore sin (Genesis 24-25; Exodus 20:14, 17, 22:19; Levities 18:22-23, 20:13, 15-16; Matthew 19: 4-6, 9; Romans 1:18-31; 1 Corinthians 6:9-10, 15-20; 1 Timothy 1:8-11; Jude 7). We believe that God created humanity male and female and that all conduct with the intent to adopt gender other than one's birth gender is immoral and therefore sin apart from natural born anomalies based on medical documentation (Genesis 1:27; Deuteronomy 22:5).

Amendment 3: Membership Amend Article IV Section 2, Members in good standing – Addition C and D C) An active involvement in the life and work of the church as it seeks to minister to all human needs. Except for those members who are incapacitated, homebound, and/or those members who are actively servicing in the military. We moreover engage that when a member moves from this place of worship to another location they will as soon as possible, unite with some other church where they can continue to grow and remain in covenant with the principles of God's Word.

D) All members must complete church orientation.

Amend Article IV section 3, Membership termination - Addition E

E) Members who are not actively involved in the life and work of the church for 90 days will receive a letter from the church regarding membership status. If they fail to respond within 30 days of receipt of the letter membership termination will occur.

 - a. Pastoral services based on Pastor's availability and discretion.
 - b. Facility
 - c. Assistance with service planning (which includes grief counseling)
 - d. Suggested Donation \$350.00
- E) Addendum: Funeral Services for Non-Members (Believers)
- F) The church will offer the following funeral services:
 - a. Use of the facility
 - b. Planning and grief counseling
 - c. Pastoral services (based on pastor's availability and discretion).
 - d. Suggested Donation \$375.00

Addendum: Funeral Services for Non-Members (Unbelievers)

- A) The church will offer the following funeral services:
 - a. Pastoral services based on Pastor's discretion and availability.
 - b. Suggested Donation \$150.00
 - c. The funeral services will have to be at the funeral home or location of the family's choosing.

Addendum to By-Laws Wedding Ceremonies Marriage counseling is a requirement for any person wanting the marriage ceremony to be per Deliverance Community Church. Marriage counseling must be initiated three months prior to wedding.
