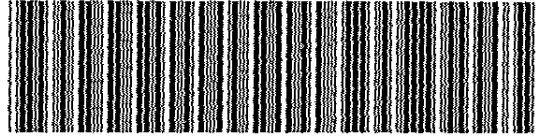

**ARTICLES OF INCORPORATION
OF

[A Not For Profit Corporation]**

The undersigned natural person, of legal age, acting as incorporator under the provisions of Florida Statutes, Chapter 617, adopts the following Articles of Incorporation:

ARTICLE I - NAME

This shall be a not for profit corporation. The name of this corporation shall be **Leesburg Sting, Inc.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
700 E. Main Street, Leesburg, Fl 34748.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to engage in the operation of an amateur girls' fast pitch softball team in the Central Florida area and to have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Florida by law may now or hereafter have or exercise.

ARTICLE IV - MANNER OF ELECTION

The affairs of this Association shall be managed by a Board of not less than three directors. The number of directors may be, as provided in the bylaws, increased but shall never be less than three directors.

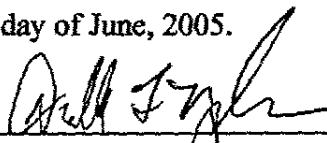

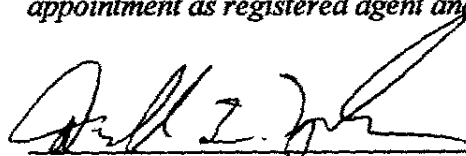
