ARTICLES OF INCORPORATION  
OF

ARTICLE ONE:

The name of the corporation is CALVARY MISSIONARY BAPTIST CHURCH OF DELTONA-OSTEEN, INC.

ARTICLE TWO:

The purpose for which this corporation is formed is to give corporate existence to the members of a religious organization known as Calvary Missionary Baptist Church of Deltona-Osteen, Inc. The object, business and purpose of this corporation is non-political and shall be devoted to the carrying out of the great commission to evangelize the World as was given by Jesus Christ to the Church in Matthew 28:19-20 for the spreading of the Gospel and Salvation of the souls of men and for the honor and glory of God, and to hold to the principles, practices, and purposes of the Inspired Word of God.

ARTICLE THREE:

The membership of said corporation shall consist only of the members in good standing of said Church known as Calvary Missionary Baptist Church of Deltona-Osteen, Inc. and none other. The qualifications of members and the manner of their admission shall be that they must first acknowledge their faith in Jesus Christ and follow him in Scriptural Baptism, by immersion, and finally shall

be admitted only by the unanimous vote of the membership.

ARTICLE FOUR:

This corporation shall have perpetual existence, and the corporate existence will convene on the filing of these Articles of Incorporation by the Department of State.

ARTICLE FIVE:

The officers who shall manage all the affairs as directed by the Church, shall be the trustees of this corporation which shall be five (5) in number and they shall serve until such time as new Trustees are elected or appointed by the Church as the By-Laws direct. The Trustees shall also constitute the Board of Directors of the corporation.

ARTICLE SIX:

The initial directors and officers who shall serve until the first election are:

ARTICLE SEVEN:

ARTICLE EIGHT:

The By-Laws of this corporation are to be made, altered or rescinded at a meeting of the members of the corporation to be called by the officers of the corporation and at such meeting there shall be present no less than twenty-five percent (25%) of the members of the corporation qualified to vote.

ARTICLE NINE:

The corporation shall have the power to sue and be sued, defend any and all actions and proceedings in its corporate name to the same extent as a natural person.

This corporation shall have the power to make contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bond and other obligations and secure any of its obligations by mortgage and pledge all or any part of its property, franchise or income.

ARTICLE TEN:

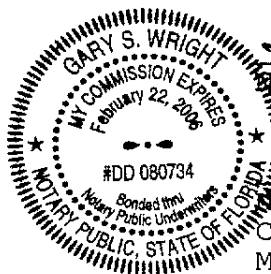

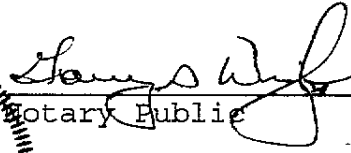
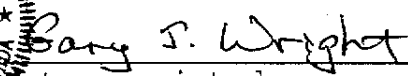
