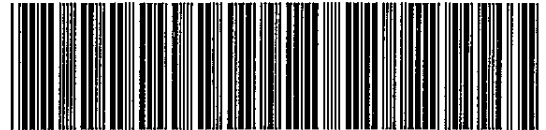

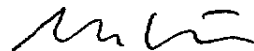

INCORPORATION OF

Pursuant to the provisions of the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, R Club of South Florida, Inc. (the "Corporation") adopts the following Articles of Incorporation:


**ARTICLE ONE
Name and Principal Office**
