ARTICLES OF INCORPORATION OF

CONCERNED PARENTS OF AUTISTIC CHILDREN, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation which were filed on June 22, 2005 and given Document Number: N05000006447.

1. Article Three is amended by adding paragraph E., which provides the following:

It is the policy of this corporation not to discriminate on the basis of race, color, national or ethnic origin in administration of its educational policies, admission policies, scholarship and loan programs, and athletic and other school administered programs.

2. Article Ten is hereby removed and replaced with the following Article Ten as follows:

Upon the dissolution, liquidation, abandonment or winding up of this Corporation and its affairs, no part of the assets and properties of this Corporation available for distribution shall inure to the benefit of any private person, except a fund, foundation or Corporation organized and operated for similar purposes, and upon any such dissolution, liquidation, abandonment or winding up of this Corporation and its affairs, after the debts and liabilities of the Corporation have been paid or adequately provided for, the assets and properties of the Corporation shall be distributed to such Foundation or Corporation, having a purpose consistent with or related to the purposes of this Corporation **and that it is exempt from taxation under Section 501(c)(3) of the Internal Revenue Code of 1986.** 3. The foregoing First Amendment to the Articles of Incorporation are hereby

approved and adopted by the members and Board of Directors of CONCERNED PARENTS

OF AUTISTIC CHILDREN, INC., effective this 15 day of February, 2007.
