Article 1

Name

The name of this Corporation shall be:

Lazarre Foundation for the Young Performer Inc.

Article 2

Principal Place and Mailing Address

The principal Office and Mailing address of the Corporation shall be:

Article 3

Purpose(s)

The purposes for which this Corporation is organized are:

- a) To promote and to encourage the young artist to progress in the art of music and fine arts**
- b) To give the young musicians the habit and the experience to perform in public**
- c) To provide therapeutic entertainment for the community at large and for the older population**
- d) To raise funds to save the arts and music schools, and to give scholarships**
- e) To encourage young children in general to major in the fine arts**
- f) To foster schools to incorporate music programs in their curriculum, because it enhances and promotes great scores academically**

Nature Article 4

The general nature of this corporation shall be exclusively for the Arts, literacy in music education, and progressive learning purposes within the meaning of section 501(c)(3) of the Internal Revenue Code

Article 5

This corporation shall have and exercise all powers conferred upon not for profit corporations under the law of the State of Florida generally, and specifically as to

provide in section 501(c)(3) of the Florida not for profit Corporation Act, provided however, that this corporation has no power to engage in any activity that in itself is not in furtherance of its purposes as set forth in subparagraphs (a) of this Article III

Article 6

This corporation shall generally possess all the powers, rights, privileges, capacities, and immunities, for which non-profit corporations are authorized, and may hereafter be authorized according to the law or laws of the state of Florida, to collect, to receive, take hold lease, purchase, improve, sell mortgage, or otherwise dispose of personal, real, or mixed property in any such manner permitted by law to the end that the purposes herein set out may be properly accomplished, and to receive by donation or otherwise any sums of money, good or real property which any person, form, or corporation should see fit to donate to this corporation for the progress of the School of the Arts.

Article 7

Term of Existence

This corporation shall have perpetual existence

Article 8

Officers

The officers of the corporation shall be President, Vice President, Second Vice President, Secretary, Treasurer, and other officers as may be provided in the bylaws

Article 9

Initial officers and/or directors

The names of the persons who shall serve as officers of the corporation until the first meeting of the Board of Directors are:

Article 10--By-LaW

The By-Laws of this Corporation may be made, altered, rescinded, added upon, or new by-laws may be adopted by a resolution of a majority of the Board of Directors, subject to any limitations contained in the By-Laws, and any limitations on corporations organized under Chapter 617 of the Florida Statutes concerning

corporate action that must be authorized.

Article 11—Amendments

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for the charitable purposes and which has established its tax exempt status under Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954, or corresponding provisions of subsequent federal tax laws.


