ARTICLE I

The name of this corporation is Orlando International Art Inc.

Section 1: The purposes for which this corporation is organized shall be to promote art and classical music in the community.

Section 2: Orlando International Art Inc shall engage in any and all lawful activities that are permitted by Chapter 617, Florida Statutes, as the same may be amended from time to time, and Section 501 © (3) of the Internal Revenue Code of 1954.
