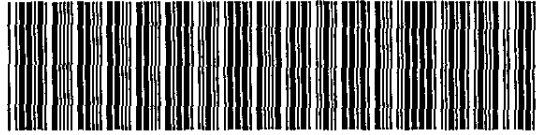

**Articles of Incorporation
Of
New Fellowship Baptist Church of Tampa, Inc.**

The undersigned, being natural persons over eighteen years of age, pursuant to Article 1396-3.02 of the Florida Non-Profit Corporation Act, set forth the following Articles of Incorporation:

Article 1

The name of the corporation is New Fellowship Baptist Church of Tampa, Inc.

Article 2

The corporation is a non-profit corporation.

Article 3

The period of duration of the corporation is perpetual. In the event that this church ever ceases to be a Southern Baptist Church, all property and assets will revert back to the Tampa Bay Baptist Association or Florida Baptist Convention.

Article 4

The corporation is organized exclusively for religious, charitable, and educational purpose within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986. (or corresponding provision of any future United States Internal Revenue law)

Article 5

The street address of the registered office of the corporation is 3810 East Emma Street, Tampa, Florida and the name of the registered agent located at such address is James Anderson. *33610 The principle place of business is the same as the registered office.*

Article 6

The corporation shall have members. The affairs of the corporation shall be managed by the Board of Directors. The number of the Directors shall be fixed by the bylaws of the corporation but may not be less than three (3).

Article 7

Article 8

Article 9

No part of the net earning of the corporation shall insure to the benefit of or be distributable to its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 4.

Article 10

No substantial part of the activities of the corporation shall be the carrying on the propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or interence in (including the publishing or distribution of statements) any political campaign on be half of or in opposition to any candidate for public office.

Article 11

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against applicants, students, employees, and others on the basis of race, color, or national or ethnic origin.

Article 12

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, transfer all assets to a fund, foundation, or organization which is organized and operated exclusively for charitable, religious, or educational purposes and shall at the time qualify as an organization exempt from Federal income taxation under Section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Article 13

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 9c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United Sate Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

In Witness Whereof, the undersigned, being the incorporators of this corporation, have executed the Articles of Incorporation this 25th day of June, 2004.
