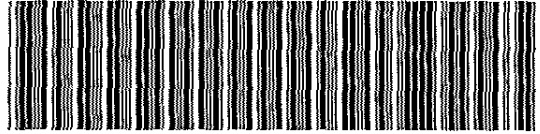
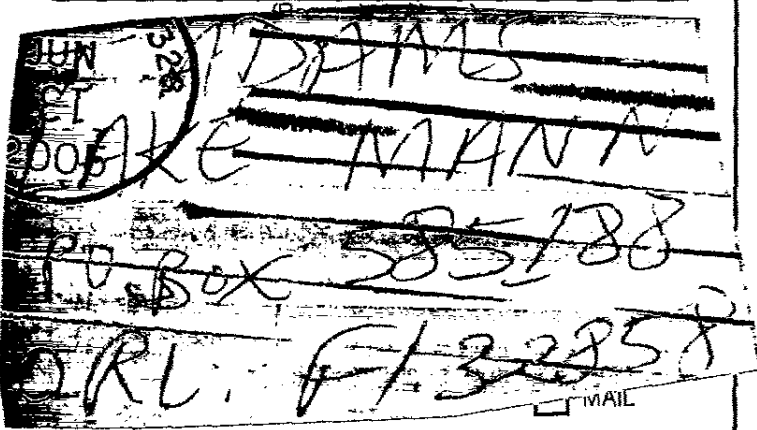

ARTICLE I. CORPORATE NAME

**The name of this corporation is
Lake Mann Ivey Lane YMCA Center Restitution Council, Inc.**

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. TERM OF EXISTENCE

The period of duration of this corporation is perpetual.

ARTICLE IV. PURPOSES

The purposes for which the corporation is organized are:
To Serve as a Christian Restoration Council in the Lake Mann Ivey Lane
and Surrounding Areas of Orange County and Central Florida;

- a. To develop buildings and Land Utilization for Christian – Based After School tutoring and Educational Programs and Recreational, Educational, Character Restoration and Community Improvement Programs,
- b. Housing and Economic Development Research and Training, Employment Preparation and Counseling, Swimming and Life Saving Services, Aquatic and Marine Life Studies and Family Development, .Food distribution , and community feeding services Operations, nutrition education health education and water sports, fitness education and transportation services, youth Programs, senior programs and family enrichment seminars, Rehabilitation, and
- c. Anti-Recidivism Education Programs.

b. To develop and implement a certification program for energy efficient and sustainable affordable home building development and construction inspection and safe harbor practices.

Such program will be open to interested residents, program managers, regardless of whether they are a member of this organization.

Provided however, that such program will not replace the requirements established by any agency or board, that is currently serving these same purposes, and this organization will foster total public Safety and Efficiency Code Requirements of all Florida and Federal Regulations.

This Corporation shall build, own operate and finance; Community Food bank Services provide Community Services Buildings and provide for ordinary testing and inspection procedures used by individual food services locations that the corporation will own, manage and operate.

To administer Community Food Services certification programs based upon the State of Florida standards;

Further goals and purposes of this corporation are: to Seek Restitution for The Ivey Lane thirteen Acres of Land that were donated to the Ivey Lane and Surrounding Community for the Development of a YMCA Center that was taken away by Political Means, and restore the Same Amount of Land on Ivey Lane, Lake Mann for the Building and Development of a Full service YMCA Type Operation and Family Services Organization, with Orange County Government, Federal and State as well as Foundation and Membership Support as all other Communities in Central Florida have been Treated with millions of our tax Dollars.

We will sponsor programs to:

1. Educate the general public, businesses, institutional and governmental bodies of the Long term benefits of sustainable development and construction of Community Healthy and Fitness Services and Food Services organization.

2. To promote and educate the public about Safe Affordable Food Preparation and Distribution Services and -practices;
3. To improve the energy efficiency, energy conservation potential, indoor air quality, Water Safety and Boating safety, and Water conservation potential and sustainability of food services buildings;
4. To encourage Safe Affordable Food Preparation and Distribution Services and - affordability by increasing building sustainability;
5. To stimulate statewide acquaintance and fellowship among members and others interested in Safe Affordable Food Preparation and Distribution Services and -practices;
6. To provide opportunities for members and other interested parties to increase their Knowledge of Safe Affordable Food Preparation and Distribution Services and -practices.

ARTICLE V. MEMBERS
