**ARTICLES OF INCORPORATION
OF
YBOR PARENTS, ALLIES, CORPORATIONS, and KIDS, INC.**

The undersigned as incorporator of the corporation, pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporations.

ARTICLE I – CORPORATE NAME

The name of this corporation shall be Ybor Parents, Allies, Corporations, and Kids, Inc. The principal place of business and mailing address of this corporation shall be: 2205 North 22nd Street, Tampa, Florida 33605.

ARTICLE II – PERIOD OF EXISTENCE

The period of duration of this non-profit corporation is perpetual unless dissolved according to law.

ARTICLE III – PURPOSE

This non-profit corporation is organized to create a resource network and unity among children and families who reside in East Ybor City, Tampa, Florida. The corporation shall promote interest in, but not be limited to educational enhancement, wholesome recreational opportunities, multi-directional family interaction, and the active engagement in and progressive mobility within community-related policy-making organizations.

ARTICLE IV – POLICY

This non-profit corporation shall not endorse a candidate for public office. Neither the name of this corporation nor the name of any officers or directors in official capacity shall be used in any connection with a commercial concern or with any political interest, provided, however, that this corporation may endorse or oppose pending legislation and assume a stand on matters of public policy if so recommended by its members in furtherance of its purpose as stated herein.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE V – MEMBERSHIP

The membership of this corporation shall consist of: Children and adults who reside in East Ybor City, businesses which operate in the neighborhood, non-resident owners of real estate in East Ybor City, and other concerned citizens. Provisions for qualifying, classifying, admitting, and terminating members shall be made in the by-laws.

ARTICLE VI – BOARD OF DIRECTORS

The board of directors shall consist of five (5) members of the organization. The manner in which directors are elected or appointed is as stated in the bylaws.

ARTICLE VII – BYLAWS

The by-laws of this corporation shall be adopted and from time to time amended by a majority vote of the active members present at a duly called meeting.

ARTICLE VIII – AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended at a properly noticed general meeting of the membership provided the amendment has been put in writing and mailed to the members at least ten (10) days prior to the meeting at which a vote of such amendment occurs. If the amendment is approved, a certified copy shall be filed with the Secretary of the State of Florida, and shall become effective upon approval of same.

ARTICLE IX– SUBSCRIBERS


