ARTICLES OF INCORPORATION OF SILVER SPRINGS LIONS CLUB FOUNDATION, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes (Not for Profit), adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Silver Springs Lions Club Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 2169 N.E. 14th Street, Ocala, Florida 34470.

ARTICLE III PURPOSE

The purposes for which the Silver Springs Lions Club Foundation, Inc. is organized are:

- A. Exclusively for charitable and educational purposes within the meaning of section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. To solicit, collect and otherwise raise money to fund those aims and goals of the Silver Springs Lions Club Foundation, Inc., including the rent, lease or purchase of property and/or buildings in which to conduct its charitable activities within the meaning of section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV MEMBERSHIP

All members in good standing of the Silver Springs Lions Club, chartered by the International Association of Lions Clubs on December 16, 1958, shall be members of the Silver Springs Lions Club Foundation, Inc.

ARTICLE V BOARD OF DIRECTORS

The affairs and business of the corporation shall be managed by a board of directors elected annually by members of the corporation at its annual membership meeting. Nominations and election of officers shall be conducted in compliance with Article IX "Elections" of the Constitution and By-Laws of the Silver Springs Lions Club.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501©(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
