Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Florida statute, Chapter 496, do hereby certify:

Article 1:. The name of the corporation shall be the International Caribbean Association of Naples

Article 2: The place in this state where the principal office of the Corporation is to be initially located is the City of Naples, in Collier County. 4397 20th Ave. 510 No-Ples, Fl. 34116

Article 3: Said corporation is organized exclusively for charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501©) (3) of the internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is to promote the social and economic welfare, as well as community alliance, among Carribean people within the Naples community.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any power that are not in furtherance of the purposes of the corporation.
