TO
ARTICLES of INCORPORATION
OF

First Step of the Eighteenth Judicial Circuit, Inc.

First Step of the Eighteenth Judicial Circuit, Inc, a Not for Profit Corporation organized and existing under the laws of the state of Florida, under certificate filed in the office of the secretary of state on June 30, 2005, (Document # N05000006721), hereby adopts the following amendment(s) to its Articles of Incorporation:

1. Article III of Incorporation of First Step of the Eighteenth Judicial Circuit, Inc. be amended to:


Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organization that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

2. Article VIII of Incorporation of First Step of the Eighteenth Judicial Circuit, Inc. be added as:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

There were no members or members entitled to vote of the amendment(s). The amendments were adopted by the board of directors.
