## ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF VEROLAGO HOMEOWNERS ASSOCIATION, INC.

The Articles of Incorporation of Verolago Homeowners Association, Inc. were filed with the Florida Secretary of State on June 29, 2005. The same Articles of Incorporation were Amended and Restated at Official Records Book 1961, Page 2248, et. seq., and are hereby amended as adopted by at least sixty-seven (67%) percent of the members by written consent on October 26, 2018.

1. Article 13 is amended to read as follows:

Article 13. <u>Amendments</u>. Amendments to these Articles may be adopted upon a resolution of the Board and the affirmative vote or written consent of Members representing at least a majority of the Class "A" votes in the Association. No amendment may be in conflict with the Declaration.

(The balance of the Articles of Incorporation remains unchanged.)

- 2. The foregoing amendment to the Articles of Incorporation of Verolago Homeowners Association, Inc. was adopted by sixty-seven (67%) percent of the members by written consent.
- 3. All provisions of the Articles of Incorporation of Verolago Homeowners Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
