Article 1 Name:

The name of the corporation shall be: Human Rights Awareness on Campus Inc.

#### Article II Principle Office:

University of Florida Department of Political Science 234 Anderson Hall, box 117325 Gainesville, Fl 32611

### Article III Purpose:

This non-profit organization strives to educate and encourage activism on issues regarding human rights violations, particularly genocide. These goals will be achieved through grass-roots organization including, but not limited to, signature collection, demonstration, information distribution and presentation, and fundraising.

#### Article IV Manner of Election:

Section 1: Elections of new officers will take place in March and will become effective at the end of the University of Florida semester.

Section 2: Any full member can be nominated for any office.

Section 3: Members who are running for office must give a three minute speech followed by a two minute Q&A session.

Section 4: Officers must be elected by simple majority by secret ballot and public count.
