## **Articles of Dissolution**

### **Article I Name of Corporation**

The name of this Corporation is Human Rights Awareness on Campus Inc., Document Number N05000006797, originally filed for incorporation on June 30, 2005.

### **Article III Reasons for Dissolution**

These Articles of Dissolution are being voluntarily filed based on the grounds set forth in F.S. Chapter 617.1430 regarding judicial dissolution. In a proceeding by the President and Director of the corporation, it has been established under F.S. Chapter 617.1430 (2) (a), that the directors are deadlocked in the management of corporate affairs and that they have ceased to be functional as a governing body; that irreparable injury to the corporation has been suffered (as stated in F.S. Chapter 617.1430 (1) (a) (2.)); that conducting or continuing corporate affairs is unfeasible given current circumstantial difficulties between members of the board; that accounting for the assets of the corporation has proved unfeasible for the aforementioned reasons; that legal counsel was sought to discuss the advisability of filing Articles of Dissolution with the Florida Department of State.

### **Article IV Regarding Debts**

This corporation has no outstanding debts to pay to the State of Florida

### **Article V Authorization of the Incorporator**

The incorporator of this corporation has authorized the filing of these Articles of Dissolution.

### **Article VI Members of the Corporation**

This corporation has no members besides the board of directors which may vote on enacting Articles of Dissolution.

3. All liabilities and obligations of this corporation have been paid and discharged.

#### **Article VIII Effect of Dissolution**

The dissolution of this corporation shall be effective on the filing date of these Articles of Dissolution.

*These Articles of Dissolution were filed under strict observation of the Florida State Statutes regarding Not for Profit corporate dissolution and are intended to follow the legal provisions of the Law to the fullest extent given the constraints of the situation, being that it is currently impossible for this corporation to continue to conduct its affairs in accordance with Florida State Law.*




