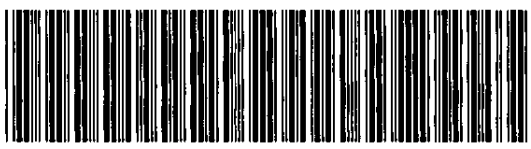

**Articles Amendment :**

**Bethesda Tabernacle of The Christian and Missionar Alliance, Inc.**, is a nonprofit corporation organized and operated exclusively for religious purposes an dis not formed for pecuniary profit or financial gain.

The purpose of the corporation is to act and operate as an accredited church of The Christian and Missionary Alliance, a Colorado nonprofit corporation, and shall accordingly act only under ecclesiastical authority and subject to the usages, doctrines and teachings of The Christian and Missionary Alliance, promulgating such doctrines and teachings, preaching the Gospel to every creature, edifying the Christians through the education of God's word, promoting spiritual fellowship among God 's people on the basis of the biblical faith, and promoting religious activities and to further other religious, educational, and charitable work to that end.

**Nonprofit dissolution clause:**

Upon the dissolution of the Corporation, or upon Corporation's termination as an accredited church of The Christian and Missionary Alliance, all of the Corporation's assets remaining after payment of or provision for all of its liabilities shall be distributed to and become the property of the incorporated or supervising body of The Christian and Missionary Alliance within whose ecclesiastical jurisdiction said Corporation is located provided that at such time the incorporated or supervising body to receive any assets of the Corporation is itself an exempt organization described in section 501(c) (3) of the Internal Revenue Code, as amended or supplemented. If the incorporated or supervising body is not, at the time of dissolution, an exempt organization described in section 501(c) (3) of the Internal Revenue Code, or is no longer in existence, all of the Corporation's assets remaining after payment of or provision for all of its liabilities shall be paid or transferred to one or more exempt religious organizations that are described in section 501 (c) (3) of the Internal Revenue Code. In such case, the organizations to receive such property shall be designated by the board of directors of The Christian and Missionary Alliance or its successor.
