**ARTICLES OF INCORPORATION
OF

We, the undersigned, citizens of the State of Florida, pursuant to Chapter 617 Florida Statutes, have associated ourselves together, and do hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit pursuant to the following Articles of Incorporation.

ARTICLE I – NAME

The name of the Corporation shall be GIVE THEM A CHANCE FOUNDATION, INC., and it shall be hereinafter referred to as GIVE THEM A CHANCE FOUNDATION, INC.

ARTICLE II – ADDRESS

Its principal office shall be in Umatilla, County of Lake, and State of Florida. The mailing address is P.O. Box 1092, Umatilla, FL 32784.

ARTICLE III- PURPOSES

The primary purpose for this corporation is to operate for the enhancement of the quality of life for high school students by preparing them for college, for military or for jobs. We will provide them with information on how to take advantage of financial aid and scholarships that are available for them. By doing this we provide an avenue that will guide young Afro-American students the opportunity to go to college, go to military or prepare them for jobs which equip them to be future leaders of their generation.

ARTICLE IV- BOARD OF DIRECTORS

1. The affairs and business of the corporation shall be conducted by a Board of Directors of the Foundation, composed of not fewer than five (5) nor more than fifteen (15) members, the exact number of which shall be fixed by the Board of Directors of the Foundation, one of whom shall be elected Chairman and another Vice Chairman. The Board of Directors shall also elect a Treasurer and Secretary.
2. In the event of a vacancy on the Board of Directors of the Foundation by reason of death, resignation or termination, the Board of Directors of the Foundation shall be authorized to fill such vacancy.
3. The Board of Directors of the Foundation shall establish an Executive Committee.
4. Annually the Board of Directors shall meet with Executive Committee to review its goals of Foundation.


