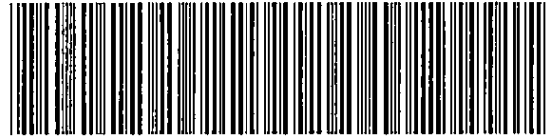

**ARTICLES OF AMENDMENT TO  
AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
FLORIDAYS ORLANDO RESORT CONDOMINIUM ASSOCIATION, INC.**

(a Florida corporation not-for-profit)

PURSUANT to the provisions of Section 607.1006 of the Florida Business Corporation Act, **FLORIDAYS ORLANDO RESORT CONDOMINIUM ASSOCIATION, INC.**, a Florida nonprofit corporation, hereby adopts the following for such corporation.

1. The present name of the nonprofit corporation is **FLORIDAYS ORLANDO RESORT CONDOMINIUM ASSOCIATION, INC.** (the "Corporation").

2. The Corporation was incorporated in the State of Florida on July 7, 2005 and assigned Document Number N05000006952 by the filing of its original Articles of Incorporation with the Florida Secretary of State, and that these Articles of Amendment to Amended and Restated Articles of Incorporation (this "Amendment") shall amend those certain Amended and Restated Articles of Incorporation filed with the Florida Secretary of State on March 17, 2006.

3. Article I of the Corporation's Amended and Restated Articles of Incorporation is hereby amended in its entirety to read as follows:

**ARTICLE I**

Name

The name of the corporation shall be **DCP IDRIVE CONDOMINIUM ASSOCIATION, INC.** For convenience this corporation shall be referred to as the "Association".

4. Subject only to the amendments herein specifically set forth, the Amended and Restated Articles of Incorporation are and shall remain in full force and effect.

5. This Amendment was adopted and approved by the Board of Directors of the Corporation on the 6th day of November, 2019.

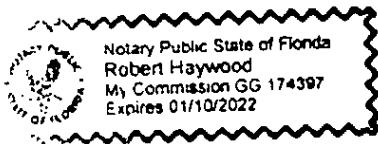
