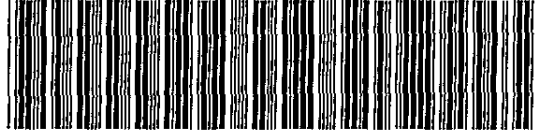

## ARTICLES OF INCORPORATION

of

A not for Profit Corporation

### ARTICLE 1

#### 1. Name

The name of the Not-for-Profit Corporation is Inner City Development, INC.

### ARTICLE II

#### 2. Principal Office

The principal place of business and the mailing address of this corporation shall be 8491 NW 23rd Avenue, Miami, FL 33147.

### ARTICLE III

#### 3. Purposes

The purpose of this non profit corporation shall be to provide classroom education, job readiness and on-the-job training to those in under-served ethnic groups. Individuals will be prepared to better serve the community and increase the economic state of our society.

The purposes for which the corporation is organized are exclusively educational and charitable within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
