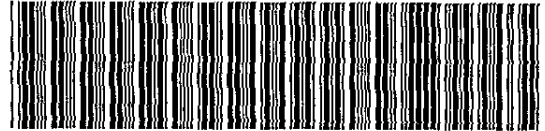

## **PREAMBLE**

In order that the witness of this Church may be born and carried out in accordance with Scriptural doctrines; that it's worship, teachings, ministry, and fellowship may be conducted in harmony with Christian principles; and that it's business affairs may be administered in an orderly fashion and in a responsible manner consistent with Biblical teachings, we do adopt and set forth this constitution and it's accompanying bylaws.

## **ARTICLE I – NAME**

**Section 1.** The name of this Church shall be Spirit Life Harvest Church of Tampa Bay, Inc.

## **ARTICLE II – PRINCIPAL PLACE OF BUSINESS**

**Section 1.** The principal place of business and mailing address of this corporation shall be at 598 Buckingham Ave West, Oldsmar, FL 34677

## **ARTICLE III – PURPOSE**

**Section 1.** The purpose of this church shall be the salvation of the lost, the Christian Education and nurture of the saved, and to glorify God and manifest His character to our community and the nations by:

- a. Worshipping God passionately.
- b. Proclaiming God boldly.
- c. Loving each other completely.

## **ARTICLE IV – OFFICERS AND DUTIES**

**Section 1.** The primary officers of this Church shall be the President, the Vice-President, the Secretary, and the Treasurer of the Board of Directors.

**Section 2.** This Church shall have such other officers as wisdom and the Holy Spirit may direct to carry out the purpose of this Church.

**Section 3.** The duties of these officers shall be those common to that office and in accordance with the scriptures. Job descriptions may be drafted for each office by the Pastor or his designated representative, and are subject to periodic evaluation by the Pastor, Elders, Trustees, and the given officer.


**Section 4.** Election and appointment of all officers shall be in accordance with the plan of the Church hereinafter provided.

## **ARTICLE V – REGISTERED AGENT & INCORPORATOR**

**Section 1.** The Incorporator and initial Registered Agent of this corporation shall be Barry Sullivan, who's address is 598 Buckingham Ave West, Oldsmar, FL 34677

## **ARTICLE VI – MEMBERSHIP**

**Section 1.** The membership of this Church shall be composed of persons 16 years of age and older who have given evidence of salvation, who have been baptized by immersion, who have subscribed to both the Membership Covenant and Constitution of this Church, and who have been received by the leadership of the Church. Acceptance for church membership shall be contingent upon one's voluntary compliance with the statement on the Application for Church Membership as indicated by the signing thereof.

**Section 2.** This Church shall dismiss from its membership those who are removed by death, those who unite with churches or organizations of other beliefs to which this Church finds in gross scriptural error, those who are removed from this Church on the basis of Scriptural discipline by the leadership, and those who may request membership to cease.

## **ARTICLE VII – COMMITTEES**

**Section 1.** The Pastor, the Board of Directors, Trustees, Staff members, Elders, and the Deacons may appoint special or ad hoc committees as wisdom and the Holy Spirit may direct as necessary for carrying on the work of the Church. On completion of the special task for which it was appointed, a special or ad hoc committee may stand or be discharged, as so determined by the Pastor or leadership.

- a. The duties of these committees shall be those inherent with the name of the committee, and adopted by the Church hereinafter provided.

**Section 2.** Establishment and appointment of committees shall be in accord with the plan of the Church as hereinafter provided.

## **ARTICLE VIII – MEETINGS**

**Section 1.** This Church shall conduct regular worship services on every Lord's day and on any other day or evening deemed appropriate by the Pastor or leadership. The Lord's Supper shall be observed at least once a month at a time deemed appropriate by the Pastor and leadership. The Church shall provide all necessary services for the Educational, Stewardship, Missionary, Evangelistic, and Promotional functions of the Church.

**Section 2.** This Church shall conduct regular business meetings every six months. The Pastor shall serve as Moderator of the business meeting. In his absence, or upon his request, a Trustee or some other person chosen by the Board of Directors may serve as Moderator.

- a. Special business meetings shall be called by the Pastor; but in the event the pastorate is vacant, a representative of the Board of Directors shall call such meetings. Any called meeting must be announced publicly at a service of the Church at least one week prior to the called meeting or by written notice to the resident membership of the Church at least one week prior to the called meeting.
- b. Members may be received into the fellowship of the Church at any worship service of the Church, as deemed appropriate by the Pastor.

## **ARTICLE IX – ADOPTION AND AMENDMENTS**

**Section 1.** This Constitution shall be considered adopted and in immediate effect if and when two-thirds of the members present at the business meeting at which the vote is taken shall vote in favor of the same.

**Section 2.** This Constitution may be amended, altered, or repealed by a two-third vote of the Board members present at any regular Board meeting of the Church, provided that such amendment, alteration, or repeal be given to the Board members for consideration at least 30 days prior to the time the vote is taken.
