
Dear Sir or Madam,

We are seeking to update our standing as a Condo Association and would like to be instated. When the Developer passed on all the paperwork, books, legal paperwork, etc., to the Board of the Condo Assoc. in 2006, we were never told we had to update anything with the Department of State, etc., or had any paperwork to do. So the registered address remained as the developer's old address (which hasn't been active in several years). In the past two years, we have never received anything from the State of Florida on updating our status or needing to put in an annual report. Actually, we've never received any paperwork or mail from the State of Florida on anything having to do with the status of our association. And because none of us on the Board had any experience with Association Boards, we never knew anything was wrong. Someone looked us on Sunbiz.org and told us about the old developer's address and information being under the Brisa del Mar Association name. That's what's lead to us trying to get reinstated and update all the information you have on us.

So we are asking that the fee be waived since we never received any paperwork from the state and since we didn't know we had to put in any paperwork. So that we are caught up to date, I've enclosed a check for \$183.75, which is 3 years of annual reports.
