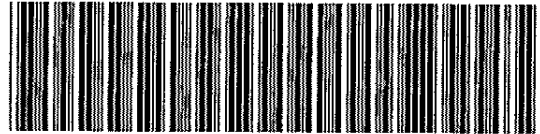

**First:**


Article I is amended to change the name of the corporation as follows:


**STARLIGHT HOLY TEMPLE CHURCH INC.**
