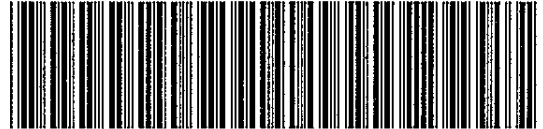

**ARTICLES OF INCORPORATION OF  
Panther Trace Civic Association, Inc.  
A NOT-FOR-PROFIT CORPORATION**

We, the undersigned, with other persons being desirous of forming a not-for-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

**ARTICLE I**

The name of the corporation shall be:

Panther Trace Civic Association, Inc.

**ARTICLE II**

The address of the principal office of this corporation shall be:

12628 Bramfield Drive  
Riverview, Florida 33569

And the mailing address of the corporation shall be the same.

**ARTICLE III**

Said corporation is a not-for-profit corporation. The specific purposes of formation are: A. To encourage civic responsibility and public welfare, and to cultivate fellowship among its members, B. To foster communication between and among the various individuals, families, groups and associations within the area, C. To provide leadership and organization that represents and coordinates community activities that encourage social and recreational pursuits and D. To further the public interest by promoting efforts toward betterment of the neighborhoods in Panther Trace.

Said corporation is organized exclusively for charitable, educational, scientific and literary purposes within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United State Internal Revenue Code.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organization which themselves are exempt as organizations described in section 501(c) (3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding section of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.




