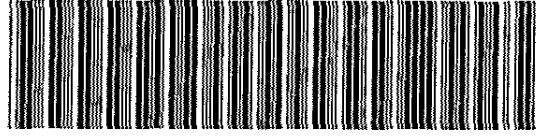

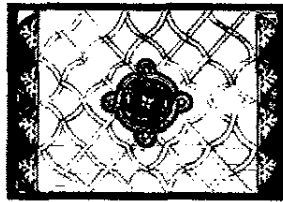

ARTICLES OF INCORPORATION
OF THE
CHURCH OF PROSPERITY, INC.

The undersigned, acting as incorporators of a corporation under the Not for Profit Corporation Act of the state of Florida, adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of the corporation, hereinafter referred to as the "Corporation" is Church of Prosperity, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 807 Kingswood Place, Brandon, FL 33511.

ARTICLE III

The following are the purposes for which this organization has been organized:
To teach good, positive values, prosperity, spiritual growth and the living of a worthwhile life. To indulge, pursue and use our God given gifts to the utmost of our abilities. To learn as many of our personal life lessons as possible in this lifetime. To endeavor to be of serve to our fellow man as to the best of our abilities. To advance the standard of living by encouraging and financing technological advancements. To encourage family self sufficiency, personal responsibility and self preservation.

ARTICLE IV

The business of this organization shall be managed by a Board of Directors consisting of three or more members. The directors to be chosen for the ensuing year shall be chosen at the annual meeting of this organization and they shall serve for a term of five years. Vacancies in the Board of Directors shall be filled by a vote of the majority of the remaining members of the Board of Directors for the balance of the term. The President of the organization by virtue of his office shall be Chairman of the Board of Directors.
