ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **Packaging & Label Gravure Educational Foundation, Inc.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **2952 Hollansburg-Arcanum Road, New Madison, OH 45346**

ARTICLE III: PURPOSE

The sole purpose of this non profit corporation is a Public Charity Corporation.

ARTICLE X: AMENDMENTS

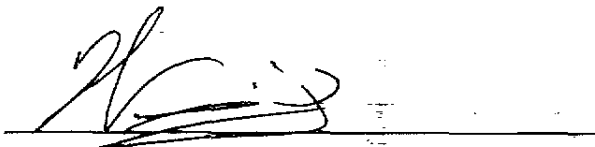
The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
