- I. The name of the corporation shall be:

Glocal Development Incorporated

- II. The street address of the initial principal office is:

- III. The purpose or purposes of this organization to be organized as a corporation for charitable purposes as specified in 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

- IV. 
