**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

I

The name of the corporation shall be: THE NORTHWEST CENTER FOR COMMUNITY DEVELOPMENT, INC.

II

The principal office and place of business of this corporation shall be at:

III

The purposes and general nature of the business to be transacted by the corporation shall be as follows:

A. Own, operate, and maintain (or rent or lease until such time it is able to purchase) facilities for use and places of counseling, support groups, treatment centers, teaching training, conducting workshops and seminars, and assembly for any other means it may deem necessary for the purpose and benefits of its members and those to whom they wish to contact;

A1. Print, publish, broadcast, and in all ways communicate and promote the ideals and benefits mentioned in the by-laws of the corporation;

A2. Receive subscriptions and donations of real and personal property to be applied to the uses and purposes of the corporation;

A3. Award certificates, diplomas, and degrees of recognition of various acts preformed or levels of instruction achieved;

A4. Do and preform such matters and things as are allowed by law and may be reasonable, convenient, or necessary to attain the objectives and ends for which it is organized as herein established.

B. To do and transact any and all business as permitted under the laws of the State of Florida and the United States of America.

Without limiting any of the purposes, powers and objects of this corporation, it is expressly declared and provided that this corporation shall have power in carrying on its own business, or for the purpose of accomplishment of any of the purposes or attainment of the objects herein above specified, to make and perform contracts of any kind and description and to do any and all other acts and things, and to exercise any and all powers, either as principal, agent or broker, conferred by the Laws of Florida upon corporations, and which a partnership or natural person could do and exercise, and which a part hereafter may be authorized by law.
