**ARTICLES OF INCORPORATION

The undersigned incorporator by these Articles associates himself for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this Corporation is Pelican Watch Condominium Owners Association, Inc.

ARTICLE II. TERM OF EXISTENCE

This Corporation is organized for the purpose of providing an entity under the Florida Condominium Act (the "Act"), for the operation of a condominium located in Franklin County, Florida, and known as "Pelican Watch, a Condominium", created pursuant to the Declaration of Condominium therefor and shall exist perpetually or until terminated as provided by law.

The purpose of this Corporation will be to operate and govern the condominium known as "Pelican Watch, a Condominium", located in Franklin County, Florida.

ARTICLE V. MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the By-Laws of the Corporation. 
ARTICLE VII. BOARD OF DIRECTORS

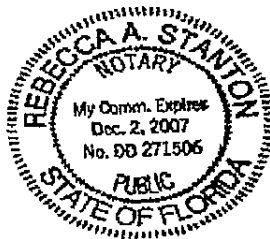
