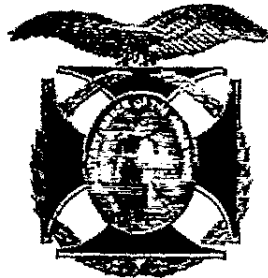

The terms, conditions and qualification with respect to the election of directors shall be as provided for by the by-laws of the corporation.


