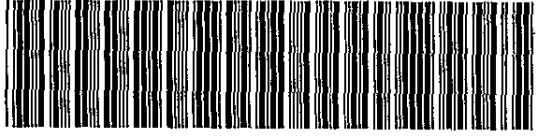

## **Articles Of Incorporation**

In Compliance with Chapter 617, F.S., (Not for Profit)

### **Article I**

The name of the corporation shall be: **Salt of the Earth Trust Inc.**

### **Article II**

### **Article III**

The purpose for which this corporation is organized is gather the monthly donation commitments of a specific list of parishioners of Our Lady Of The Rosary Catholic Church, Land O Lakes, Fl and to use these funds to support the mission efforts of Father Paul Attah-Nsiah upon his return to his Diocese of Konongo-Mampong and his Bishop, the Most Reverend Joseph Osei-Bonsu, in Ghana, Africa.

Father Paul has been resident in our parish off and on for 4 ½ years as he pursued his doctoral degree in Canon Law at the Pontifical University in Rome. During his 4 to 6 month yearly visits, assisting our priests in carrying out parish duties, Father Paul has found a very special place in the minds and hearts of OLOR parish members. 


