ARTICLE OF INCORPORATION
OF
MIRACLE FAITH DELIVERANCE OUTREACH CENTER, INC.

We, the undersigned with other person being desirous of forming a corporation under the provision of Chapter 617 of the Florida Statutes do agree to the following:

ARTICLE I

The name of this corporation is: MIRACLE FAITH DELIVERANCE OUTREACH CENTER, INC. And its principal office is located at: 4881 GRIFFIN ROAD, #404, DAVIE, FL 33314.

ARTICLE II

This corporation shall have perpetual existence unless dissolved pursuant to law. The existence shall commence upon filing with the Secretary of State.

ARTICLE III

Notwithstanding any other provision of these articles, this purpose for which the corporation is organized are exclusively charitable, scientific, literary, and educational, with the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding provision of the future United States Internal Revenue Law. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of Section 501(c)(3) purpose.

This corporation shall have the right to promote spiritual and intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, personal and mixed. To operate a daycare center, homeless, prison ministry, street ministry, feeding and clothing the homeless, providing shelter for the homeless, to have gospel programs, crusades and revivals.

ARTICLE IV

The qualification for members and the manner of their admission is to be provide for in the Bylaws.

ARTICLE V

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempted as described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code, or to the Federal State or Local government for exclusive purpose.

ARTICLE VI

The number of directors constituting the Board of Directors of this corporation are 3, and the members of the Board of Director shall be elected and hold office in accordance with the Bylaws. Members of this corporation may provide such bylaws for the conduct of its business and the carrying out its purpose as they deem from time to time.
