# **CHURCH OF CHRIST AT MARTIN LUTHER KING BOULEVARD, INC.**

## **ARTICLES OF INCORPORATION**

### **ARTICLE I - NAME**

The name of this organization shall be the Church of Christ at Martin Luther King Boulevard, Inc.

### **ARTICLE II - BUSINESS AND MAILING ADDRESS**

The principal office and mailing address of the organization shall be located at 624 South Dr. Martin Luther King Boulevard, Daytona Beach, Florida 32114 in Volusia County, Florida.

### **ARTICLE III - PURPOSE**

#### **Section 1: Purpose**

The purpose of the Church of Christ at Martin Luther King Boulevard, Inc. is to carry out the mission of the New Testament Church as prescribed by the Holy Bible. These duties include, but are not limited to: preaching and teaching of the Gospel, engaging in bible studies, caring and serving the sick and needy, caring for true widows indeed, and any other duties enumerated in the Holy Bible for the New Testament Church, also known as the Church of Christ. The Board of Directors for the Church of Christ at Martin Luther King Boulevard, Inc. shall have the authority to conduct all business matters including but not limited to: employing staff and personnel; contracting of services; receiving and distribution of all funds; obtain, hold, lease, sell, mortgage any real or personal property for the purposes of the organization; obtain and borrow funds for the purposes of the organization from private and public sources. The Church of Christ at Martin Luther King Boulevard, Inc. shall allow the Holy Bible to serve as its guide for all spiritual and scriptural matters which shall include but not be limited to the following scriptural references: Romans 16:17, II Thessalonians 3:6-7 and Acts 20:28-31. All actions and matters of the Board of Directors shall be made known to the Church of Christ at Martin Luther King Boulevard, Inc. at a quarterly meeting of the organization.

#### **Section 2: Membership**

In order to be a member of the Church of Christ at Martin Luther King Boulevard, Inc., an individual shall comply with the provision already prescribed in the Holy Bible, which are as follows: They must hear the word of God Romans 10:17; believe the Gospel Hebrews 11:6; repent of all sins Hebrews 11:6; confess Jesus Christ as the son of God before men Matthew 10:32; and be baptized, that is fully submerged into water, for the remission of sins Acts 2:38. Persons who are already members of the Church of Christ and desire to be members of the Church of Christ at Martin Luther King Boulevard, Inc. shall make their intentions known publicly and after it has been determined that they are in good standing with the previous Church of Christ, they may be added to the roster of the Church of Christ at Martin Luther King Boulevard, Inc.

### **ARTICLE IV - DIRECTORS**

The Board of Directors for the Church of Christ at Martin Luther King Boulevard, Inc. shall be comprised of no less than three and no more than five faithful brethren of the Church of Christ at Martin Luther King Boulevard, Inc. The Board of Directors shall be presented to the entire organization for consent. If any member shows scriptural reasoning to not allow a brother to be considered, his name shall be removed from the slate of brethren to serve. Until an eldership has been appointed, the minister shall always serve as a member of the Board of Directors, unless it is his decision not to serve. Each member of the Board of Directors shall serve a term of two years, with there being no term limitations. If there should be a vacancy on the Board of Directors due to a death or resignation, that slot may be filled for the remaining period of time left in that director's term with a decision of the Board of Directors and the consent of the Church of Christ at Martin Luther King Boulevard, Inc.
