**ARTICLE I NAME**

Notwithstanding any other provision of the Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from Federal Income Tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code.
