Relative Care Giver Foundations. Mission Statement

To have a support group to share and have support through these trying times family problems.

To make sure the children have their essential needs met. Such as, clothing, and the information you need to get results.

A safe haven for a relative to go and talk and share problems they are having.

To make sure relative care givers get the correct information needed to help with the process of documentation in getting assistance and other supports.

Telephone numbers to direct you to people you can trust.

Mission to save children's lives.

Help children obtain some rights to have a voice in which they can have a say in their own lives.

Be a support group who helps the children's needs met.

We will have fundraisings to help foundation.

- 1. To help with financial needs of relatives without financial aid yet.
- 2. To help with costs of printed material.
- 3. To help with office supplies such as stamps and envelopes and business cards.
- 4. To help with printing of flyers.
- 5. Gas to distribute materials and or pick up donations.

Will take all donations of clothing, toys, Hygiene items, furniture, bottles and baby items for those in need.

Main objective to keep relative care givers informed of their rights, responsibilities and choices.

What a Relative Care Giver Needs to Know

- 1. Make sure you receive court papers from CPI on day children are placed in your home.
- Read all papers carefully and decide do you want this case heard from a Master General or before a judge. You need to petition the courts in a timely manner which is a short period of time.
- 3. Find out mediation dates.
 - A. You may need to get your own lawyer.
 - B. The mediation date is when the relative to whom the children belong is given a case plan.
 - C. If you sit in on the mediation you are entitled to a case plan.
 - D. They have one year to complete case plan.
- 4. When you have been through three court dates you are entitled to relative care funding. There are other names this also may go by such as AFDC and TNA funding.
- 5. If child support is involved you need to go to your nearest child support enforcement office. You will need to change the legal documents to change payees name to yours.
- 6. You will need to apply for Medicaid for each child.
- 7. You need to document everything.
 - A. Children's behavior.
 - B. How children behave before and after parental visits.
 - C. Dr.'s Appointments.
 - D. Contact with caseworkers and all state employees.
 - E. How parents are with you.
 - F. Financial things regarding child support and relative care funds
 - G. Basically document everything.
 - H. Document important things you here the children saying.
- 8. Make sure you go to every court date. Going to court is how you find out what is actually going on.
- 9. Don't sign anything you do not get a copy of.
- 10. If visitation is supervised you can have this done with a caseworker at the DCF site or you can supervise visits. Make sure you know all the rules involved. If you supervise children parents are not to be anywhere with children alone. Not even the next room.
- 11. If you have problems in obtaining help with papers etc... Contact your local representatives in your area. You may even want to try to find a lawyer who does pro bono work to help you.
- 12. If sole unification comes to court and you haven't been heard from a guardian ad-litem and you have documentation that these children's situation will be the same as when they were presented to you, you need to get in touch with the following:

- 13. You need to be listed as Relative Care Giver in order to get child care. You are entitled to childcare for children up to 14 years old.
