ARTICLES OF INCORPORATION

C-SAW, INC.

These articles are filed in compliance with Not for Profit corporations pursuant to Chapter 617, Florida Statutes.

ARTICLE I - NAME

The name of the corporation shall be:

C-SAW, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - PURPOSE

The purposes for which the corporation is organized are:

- a. The advancement of education and/or other corresponding purposes relating to animal welfare and control
