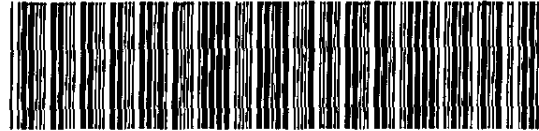

ARTICLES OF INCORPORATION
of
Diabetic Services, Inc.

TO: FLORIDA DEPARTMENT OF STATE, CORPORATION COMMISSION:

The undersigned natural person of the age of twenty-one years or more, acting as incorporator, adopts the following Articles of Incorporation pursuant to the Florida Nonstock Corporations Act:

- FIRST:** The name of the corporation is Diabetic Services, Inc.
- SECOND:** The address of its initial registered office is 320 Niblick Avenue, Orlando, FL 32804. This office is physically located in Orange county.
- THIRD:** The Corporation is organized and will be operated exclusively for charitable purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) Specifically, the corporation is organized to help persons with diabetes obtain needed supplies and fund research projects that work to find a cure for diabetes. In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by a corporation organized under the Florida Nonstock Corporations Act, whether or not related to the foregoing purposes, and to do all things necessary, proper and consistent with maintaining tax exempt status under section 501(c)(3).
- FOURTH:** The members of the Board of Directors shall be those individuals appointed, from time to time, in accordance with the Bylaws. Directors shall elect their qualified successors.
- FIFTH:** The number of directors constituting the initial Board of Directors is 4, and the names and addresses, including street number, of the persons who are to serve as the initial directors until the third annual meeting, or until their successors are qualified and elected, are:

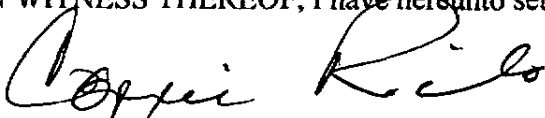

SEVENTH: The period of duration is perpetual.

EIGHTH: The internal affairs of the corporation shall be regulated by its
Board of Directors as described in the Bylaws. Upon dissolution
of the corporation, its assets shall be disposed of exclusively for
the purposes of the corporation or distributed to such organizations
organized and operated exclusively for charitable purposes that
shall, at the time, qualify as exempt organizations under section
501(c)(3).

NINTH: No part of the net earnings of the corporation shall inure to the
benefit of or be distributed to any director, employee or other
individual, partnership, estate, trust or corporation having a
personal or private interest in the corporation. Compensation for
services actually rendered and reimbursement for expenses actually
incurred in attending to the affairs of this corporation shall be
limited to reasonable amounts. No substantial amount of the
activities of the corporation shall be the carrying on of propaganda,
or otherwise attempting to influence legislation and this corporation
shall not intervene in (including the publishing or distributing of
statements) any political campaign on behalf of or in opposition to
any candidate for public office. Notwithstanding any other
provision of these Articles or of any Bylaws adopted thereunder,
this corporation shall not take any action not permitted by the laws
that apply to this corporation.
