ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF TAYLORFIELD PROPERTIES SUBDIVISION HOMEOWNER'S ASSOCIATION, INC.

Article IV of the Articles of Incorporation of TAYLORFIELD PROPERTIES SUBDIVISION HOMEOWNER'S ASSOCIATION, INC., a Florida corporation, filed in Tallahassee on the 26th day of July, 2005 is amended to add the following additional provisions as follows:

ARTICLE IV

There shall be set aside a permanent vegetative buffer ("Buffer") twenty-five (25) feet wide, over that portion of the property shown on the plat. This buffer extends across lots one (1) through fifty-five (55). The Buffer is part of the surface water management system permitted by the St. Johns River Water Management District. The purpose of the Buffer is to detain and treat stormwater prior to drainage offsite; therefore, the area must be maintained with a dense vegetative cover. Filling and placement of impervious surface (other than fenceposts) are prohibited within the Buffer.

The foregoing amendment was adopted by unanimous vote of the Directors of the corporation on the _____ day of _____ ber___, 2005, and shall become effective upon filing with the Secretary of State of the State of Florida.
