#### ARTICLES OF INCORPORATION

OF

# ORLANDO LIBERTY BIBLE FELLOWSHIP, INC.

In Compliance with Chapter 617, F.S., (Not for Profit)

IT IS HEREBY CERTIFY THAT:

### ARTICLE I: NAME

The name of the Corporation shall be::

ORLANDO LIBERTY BIBLE FELLOWSHIP, INC.,

(hereinafter called the Christian "Organization or Church ")

### ARTICLE II: PRINCIPAL OFFICE

The Principal place of Business and mailing address of this corporation shall be:

149-44 Indigo Lake Drive

Orlando, Florida, 32824

### **ARTICLE 111: PURPOSE:**

The purposes for which the corporation is organized are as follows:

The purpose of the Church is a Religious and charitable Christian non-profit organization to function and operate in accordance with the Holy Bible, Word of God and insofar as God enables:

- A. To know Christ and to make Him known.
- B. To fulfil the Biblical mandates as in Matthew 28:18-20 by the church to worship and glorify God, to evangelize the lost, to edify believers, and to foster the establishment of the Kingdom of God in this present age while awaiting for Christ's Coming.
- C. To seek, through the efforts by the ministries of the church and other means the salvation of men and women through the preaching and teaching of the Gospel of our Lord Jesus Christ.
- D. To perform, practice, engage and maintain every other lawful and religious church activities as a church body or in conjunction with other believers, churches and denominations as far as is practicable in the salvation of the lost.
- E. The church being exclusively a christian religious, non-profit and charitable organization, is to engage, promote, establish, maintain and carry on any and all but not limited to the following:
  - 1. To provide mutual support for cooperative effort and spiritual fellowship between christians and believers of the christian faith..
  - To practice, preach, teach, communicate and publish by every means the gospel teachings of our Lord Jesus Christ, as found in the Holy Bible.
  - To receive and collect on a voluntary basis tithes and free will offerings and contributions, donations, gifts and other charities, monetary and otherwise and thereby to provide cooperative effort toward fulfilling the various ministries

- mandated in the Scriptures such as establishing places of worship, meeting the charitable needs of believers and the needy in the communities and elsewhere.
- 4. In the performance of the foregoing to buy, sell, own, lease, build, construct, Develop and repair real and personal properties, mortgage, borrow and raise money from banks, corporations, agencies and individuals, and to operate and maintain and repair all personal property and real estate property and to enter into and perform and execute all contracts, deeds, titles, agreements, affidavits and other documents and proceedings necessary for such transactions and affairs in the name of the incorporated church.
- 5. To open, conduct or otherwise maintain and carry on checking, savings, deposits and other banking accounts in any banks on behalf of the church..
- To call and conduct board meetings, annual church meetings, seminars, conferences and other church meetings periodically in order to manage the affairs of the church.
- To make, modify, ratify and adopt suitable articles of constitution and bylaws for the policy, administration and management of the businesses and affairs of the church.

#### FEDERAL TAX EXEMPTION

8. Notwithstanding any other provisions of these articles, the church is organized exclusively for one or more of the purposes as specified in section 501 (c) (3) of the Internal Revenue Code, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code, or corresponding provisions of any subsequent

Federal or State tax laws.

- No part of the net earnings of the church shall inure to the benefit of any member, trustee, director, officer of the church, or any private individual (except that reasonable compensation may be paid for services rendered to or for the church), and no member, trustee, officer of the church or any private individual shall be entitled to share in the distribution of any of the church assets on dissolution of the corporation.
- 10. No substantial part of the activities of the corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.
- 11. In the event of dissolution of this church, all of the remaining assets and property of the church shall, after making the necessary deduction and expenses thereof, be distributed to such organization or church body as shall be decided by the church board and as shall qualify under section 501 (c)(3) of the Internal Revenue Code or other laws, subject to the approval of a judge of the Florida Supreme Court.

#### ARTICLE IV: MANNER OF ELECTION

The manner in which the directors are elected or appointed is as follows:

GOVERNING BOARD

1. The Board of Directors of the church shall be a permanent self-perpetuating and appointed Governing Board of individuals composed of The President, Vice

- President, Secretary, Treasurer, Evangelism chairman, Mission Chairman, and any other advisory individuals which the Board shall consider necessary.
- 2. Members of the Board for the time being for the purpose of this Article of Incorporation shall be:
  - Michael C. Persaud, President and Senior Pastor; Joseph M. Persaud, Vice President and Associate Pastor;; Mahase Singh; Secretary; Ronald Dalloo: Mission and Evangelism Chairman; and Mahendra William: Treasurer.
- The President and or the Vice President shall recommend and the governing board shall appoint individuals to be Board members.
- 4. The governing Board shall hold annual and other board meetings to handle and transact the business of the church.
- 5. The Governing Board shall be recognized as the highest decision making body of the church and shall have final authority in all matters of the church.
- The President and Senior Pastor shall appoint committees to help administer and mange the business of the church.
- 7. The Governing Board shall serve as a ministerial and credential committee for the purpose of issuing and granting local preachers certificates, ministers certificates, Ordination Certificates and any other certificates on behalf of the church.
- 8. The President and or the Vice President or other designated and appointed officers of the church shall be responsible to transact all the legal and other business of the church.
- The President and or Vice President or other officers so designated shall sign and validate any document on behalf of the church.

10. The President and or Vice President or other officers so designated shall hold church and worship and other services, call and hold annual church meetings and other meetings, subject to the approval of the governing board.
