In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **DESOTO DISASTER RECOVERY, INC.**

ARTICLE II

The existence of the Corporation shall begin on the date of the filing of the Articles of Incorporation, and the Corporation shall exist perpetually.

ARTICLE III

The street address and mailing address of the principal office of the Corporation is **200 West Oak Street, Arcadia, FL 34266**. The purposes for which the corporation is organized are exclusively charitable, scientific, literary and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV

Membership in the Corporation shall be as provided for in the Corporation's By-Laws.

ARTICLE V

The initial street address of the Corporation's registered office is **200 West Oak Street, Arcadia, FL 34266**. The initial registered agent for the Corporation at that address is **David Laubhan**.
