**Articles of Incorporation**  
**of**  
**Klif4Kids, Inc.**  
**A Nonprofit Corporation**  
In Compliance with Chapter 617, F.S. (Not for Profit)

Articles of Incorporation of the undersigned, a majority of who are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Florida, do hereby certify:

**Article 1:** The name of the corporation shall be Klif4Kids, Inc.

**Article 2:** The principle place of business and mailing address of this corporation shall be:  
13400 Sutton Park Drive South  
Suite 1601  
Jacksonville, FL 32224

**Article 3:** Klif4Kids, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organization under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is to cooperatively involve the efforts of friends, family, and community sponsors to represent the ideals and pursuits of Karl Klifton Kramer IV. Klif4Kids, Inc. will provide enrichment for participants while contributing to the establishment and continuation of programming that encourages fellowship, teamwork, personal achievement, and character development for children with disabilities and underprivileged youth in the Jacksonville metropolitan area.

**Article 4:** Klif4Kids, Inc. shall have seven (7) directors and five (5) officers with specifically defined responsibilities. Upon the annual election of directors, persons present at the formal, electoral meeting will be permitted to make nominations for the director positions. Once the nominations are recorded, the meeting attendees will vote on the recommended names by secret ballot. The Board of Directors will hence be elected by a majority rule and will subsequently appoint members of the corporation to serve in the designated officer positions.

**Article 8:** No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of Klif4Kids, Inc.

**Article 9:** Upon the dissolution of Klif4Kids, Inc., assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of Duval County, exclusively for such purposes or to such organizations, as the said Court shall determine, which are operated exclusively for such purposes.
