

### Article I

### Name

The name of the corporation is Hospitality Industry Foundation, Inc.

### Article II

# Principal Place of Business

The principal place of business shall be located at the offices of the Daytona Beach Area Convention and Visitors Bureau, Inc., 126 E. Orange Avenue, Daytona Beach, Florida, 32114. The location of the offices may be changed from time to time at the discretion of the Board of Directors.

### Article III

# Corporate Purpose

The Hospitality Industry Foundation, Inc. has been organized exclusively for charitable, educational and scientific purposes under section 501c3 of the Internal Revenue Code, or corresponding section of any future tax code. The foundation will engage in the following activities:

- 1. Implement and grow all program that provides educational scholarships and training opportunities to individuals employed, or seeking employment, in the hospitality industry.
- 2. Increase the visibility of, and support for, the local hospitality industry by organizing and producing events and activities which provide funding for targeted charitable organizations.
- 3. Fund, conduct and publish research studies which provide a platform for sustainable tourism as a viable economic generator for the community.
- 4. Create programs designed to educate the public about the multi-cultural, historical and ecological assets of Volusia County, Florida.

### Article IV

# Management

The affairs of the corporation shall be managed by a Board of Directors. For the purposes of section 617.041, Florida Statutes, all voting rights shall be vested in the Board of Directors. The Board of Directors shall be comprised of the following:

- 1.) President/CEO of the Daytona Beach Area Convention and Visitors Bureau
- 2.) Chairman of Halifax Area Advertising Authority
- 3.) Chairman of Daytona Beach Area Convention and Visitors Bureau

Additional members may be added from time to time at the discretion of the Board of Directors.

The term of service for each member of the board shall be concurrent with the term of the organization they represent. Officers shall be a President, Vice President and Secretary Treasurer, and will be elected annually.
