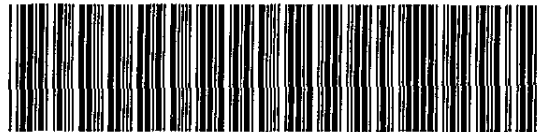

Articles of Incorporation

The undersigned, acting as incorporators of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopt the following articles of incorporation for such corporation.

Article I

The name of the corporation is: Mission Deliverance, Inc. And the principle address of the corporation is:

12811 N. Nebraska Ave. Unit G., Tampa, FL, 33612

Article II

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing.

Article III

The purposes for which the corporation is organized are as follows:

1. To establish and maintain a local congregation of Mission Deliverance, Inc.
2. To spread the Gospel of Jesus Christ, promote holiness and the worship of God among its members and attendants, and the practice of Christian virtues as admonished by the Holy Scriptures.
3. To employ and discharge ordained, licensed, and commissioned ministers of the Gospel, and others, to conduct and carry on divine services at a place of worship, and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of said corporation and ecclesiastical body being the local congregation known as Mission Deliverance Inc.
4. To provide appropriate religious education and training for its members and those attending its church school and other educational meetings and classes.
5. To acquire property, real, personal or mixed, by purchase, gift, legacy, bequest, or in any manner and to borrow money, issue bonds or notes, and all other documents necessary or appropriate in carrying out the objects and purposes set forth in this article III.
6. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the purposes stated herein stated, or incidental to the powers named, or which shall at any time appear conducive or expedient for the promotion of its welfare, and the accomplishment of the purposes herein stated.

7. All of the purposes and powers of the corporation shall be subject to and in accordance with the By-Laws of Mission Deliverance, Inc..

Article IV

The terms of admission to membership in this corporation shall consist of membership in good standing in the ecclesiastical body known as Mission Deliverance, Inc. and each member in good standing in such ecclesiastical body shall by virtue thereof be a member of this corporation.

Article V

The affairs of the corporation shall be managed by a Board of Trustees, which shall consist of not less than (3) three and not more than (9) nine members of the corporation in good standing. The number, tenure of office, manner of election and filling of vacancies shall be provided by the BY-Laws of the corporation. The initial members of the Board of Trustees and their respective addresses are:

ARTICLE VIII

This corporation is organized under Section 501 (c) (3) of the internal revenue code. In the event of the dissolution of Mission Deliverance Inc. the assets of the corporation shall be distributed to its members under the direction of the Board of Trustees.

ARTICLE IX

The officers of the corporation are the incorporators. The officers of the corporation shall consist of a President, a Secretary and a Treasurer. The Secretary and Treasurer may be the same person. The manner of election, tenure of office and filling vacancies shall be provided by the By-Laws of the corporation. The initial officers of the corporation are as follows:

These Articles of incorporation may be amended by a vote of (2/3rds.) two-thirds of the members present at an annual meeting or special meeting called for such purpose, provided that notice of the proposed amendment shall be given to the membership in accordance with the provisions of the By-Laws.


