The undersigned, as the incorporator of a Florida not-for-profit corporation pursuant to Section 617.02011, Florida Statutes (2004), hereby delivers the following Articles of Incorporation to the Department of State:

**ARTICLE 1
NAME OF ASSOCIATION AND PRINCIPAL OFFICE**

The name of this corporation shall be BOB GRAHAM CENTERS, INC. The principal office is 212 Stuart Avenue, Lake Wales, Florida 33853.

**ARTICLE 2
PURPOSE**

The purpose of Bob Graham Centers, Inc. is to focus student teaching, scholarly research, and the external support of the University of Florida and the University of Miami within designated program areas, and to provide a public service by undertaking certain research projects designed to arrive at practical solutions to specific public problems.

**ARTICLE 3
