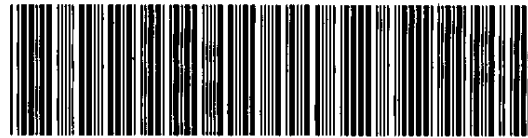

**FIRST:**


**Article I is hereby amended as follows:**
