# ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TOLL AHASSES FLORIDA

# PERDIDO GARDENS MASTER HOMEOWNERS ASSOCIATION, INC. (A Corporation Not for Profit)

THE UNDERSIGNED INCORPORATOR to these Articles of Incorporation hereby proposes the incorporation under Chapter 720, Florida Statutes, of a corporation not for profit, and hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida, Articles of Incorporation, and hereby certifies as follows:

#### ARTICLE I: NAME AND LOCATION

The name of this corporation shall be PERDIDO GARDENS MASTER HOMEOWNERS ASSOCIATION, INC. (hereinafter referred to as the "Master Association" or "Association"), and its initial office for the transaction of its affairs shall be 36132 Emerald Coast Parkway, Suite 1, Destin, Florida, 32541.

#### ARTIGLE II: PURPOSES

The Master Association does not contemplate pecuniary gain or profit to the members thereof, and no distribution of income to its members, directors or officers shall be made, except that nothing herein shall prevent the Master Association from compensating persons who may be members, directors or officers in exchange for services actually rendered to, or costs actually incurred for the benefit of, the Master Association in furtherance of one or more of its purposes. The general purpose of this Master Association is to promote the common interests of the property owners in Perdido Gardens, which property is more particularly described in the Declaration (herein referred to as the "Property"), and in any property that may later be submitted to the jurisdiction of this Master Association, and the specific purpose is to perform the functions of the Master Association contemplated in the Declaration of Covenants, Conditions and Restrictions for the Property as recorded in the public records of Escambia County, Florida (herein referred to as the "Declaration"), as the same may in the future be amended from time to time, which purposes shall include, but not be limited to, the power to:

- (a) Exercise all of the powers and privileges and to perform all of the duties and obligations of the Master Association as set forth in the Declaration;
- (b) Fix, levy, collect and enforce payment, by any lawful means, all charges or assessments pursuant to the terms of the Declaration, and to adopt such annual budgets as are necessary to carry out the provisions of the Declaration;
- (c) Pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Master Association;
- (d) Acquire, either by gift, purchase or otherwise, and to own, hold, improve, build upon, operate, maintain, convey, sell, lease or transfer, or otherwise dispose of real or personal property, leasehold estates, or interests therein, in connection with the affairs of this Master Association:
- (e) Borrow money, and upon 2/3 affirmative vote of each class of members, mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property, or lesschold, or subleasehold, or sub-subleasehold estate as security for money borrowed or debts incurred:
- (f) Dedicate, sell, or transfer all or any part of the Master Association's property to any public body or governmental agency or authority, or any public or private utility for such purposes and subject to such conditions as may be agreed to by the members;
- (g) Grant easements as to the Common Property to public and private utility companies, and to public bodies or governmental agencies or other entities or persons, without cost or charge, where convenient, desirable or necessary in connection with the development of the Property, and the providing of utility and other services thereto;
- (h) Participate in mergers and consolidation with other non-profit corporations organized for similar purposes, provided that any such merger or consolidation shall have been approved by a 2/3 vote of each class of members; ((H05000180439 3))

- (i) Adopt, alter, amend, and rescind reasonable rules and regulations from time to time, which rules and regulations shall be consistent with the rights and duties established by the Declaration and with the provisions of these Articles of Incorporation;
- (j) Contract for the maintenance and management of the Common Properties and to authorize a management agent to assist the Master Association in carrying out its powers and duties under the Declaration;
- (k) Have and exercise any and all other powers, rights and privileges of a not-for-profit corporation organized under the laws of the State of Florida.
- (I) Manage, control, operate, maintain, improve, repair and replace the Common Properties or other portions of the Property as contemplated by the Declaration;
- (m) Enforce covenants, conditions, or restrictions to the extent the Master Association may be authorized to do so under the Declaration or By-Laws;
- (n) Engage in activities that will actively foster, promote, and advance the common interests of all owners of the Property subject to the Declaration;
- (o) Exercise all of the powers, express or implied, granted to the Mester Association by the Declaration or which are reasonably necessary in order for the Mester Association to administer, enforce, carry out and perform all of the acts, functions, rights and duties provided in, or contemplated by, the Declaration;
- (p) Purchase insurance for the protection of the Master Association, its officers, directors and Members, and such other parties as the Master Association may determine to be in the best interests of the Association;
- (q) Exercise architectural control over all buildings, structures and improvements to be placed or constructed upon any portion of the Property pursuant to the Declaration;
- (r) Contract for cable television and security services within the Property as the Board in its discretion determines necessary or appropriate;
- (s) Provide, purchase, acquire, replace, improve, maintain and/or repair such buildings, attructures, street lights and other structures, landscaping, paving and equipment, both real and personal, related to the health, safety and social welfare of the Members of the Master Association and the owners and residents of the Property as the Board in its discretion determines necessary or appropriate;
- (t) Employ personnel necessary to perform the obligations, services and duties required of or to be performed by the Master Association and/or to contract with others for the performance of such obligations, services and/or duties.

# ARTICLE III: MEMBERSHIP AND VOTING RIGHTS

# A. Mambership.

- 1. Homeowners Association Member. Each Homeowners Association (as defined in the Declaration) shall be a Member of the Master Association ("Homeowners Association Member"). Such membership shall be established upon the filing of the articles of incorporation of the Homeowners Association with the Secretary of State of the State of Florida, and the recording in the public records of Escambia County, Florida, restrictive coverants or declarations subjecting all or a portion of the Property to the jurisdiction of the Master Association or providing that the Master Association will have jurisdiction over any portion of the Property.
- 2. <u>Gwner Member</u>. If any portion of the Property is not subject to the Jurisdiction of a Homeowners Association, the owner of such portion of the Property shall be a Member of the Association ("<u>Owner Member</u>"). The Owner of the Commercial Parcel (as defined in the Declaration) shall be an Owner Member during all periods of time that the said Commercial Parcel, or portions thereof, are subject to the Declaration. Such membership shall be initially established upon the recording of these Articles and the Declaration in the public records of

Escambia County, Florida.

- 3. <u>Declarant</u>. Declarant shall be a Member of the Association, regardless of whether or not Declarant owns any portion of the Property, until such time as (i) all of the Units or Planned Units to be located on property owned by Declarant which may be constructed within the Property, or on any Additional Property, or further real property as may be added to the Property, have been completed, or (ii) Declarant relinquishes its membership by written notice to the Association recorded in the public records of Escambia County, Florida, whichever occurs first.
- B. <u>Classes of Membership and Voting</u>. The Association shall have two classes of voting membership: Class A and Class B. So long as there is Class B membership, Class A members shall be all Homeowner Association Members and all Owner Members, except the Declarant. All Class B memberships shall belong to the Declarant, Upon termination of Class B membership, as provided below, Class A members shall be all Homeowner Association Members and Owner Members, including the Declarant so long as such Declarant Is an Owner (as defined in the Declaration). Class A and Class B members shall be entitled to vote in accordance with the applicable voting provisions set forth in the Declaration and in Section 12 of Article III of the By-Laws. There shall be no cumulative voting for directors or for any other matters.
- Transfer of Control of the Master Association. Transfer of control of the Master Association from Declarant to the Members of the Association other than Declarant shall occur in accordance with applicable Florida law pertaining to and regulating the operation of homeowners associations, in effect as of the date of the execution of this Declaration, (currently Section 720,307, Florida Statutes) as follows: The Members other than Declarant shall be entitled to elect at least a majority of the members of the Board of Directors upon the earlier of the following: (i) 3 months after 90% of all Units, Planned Units and Parcels which may ultimately be operated by the Master Association have been conveyed to third parties; or (ii) upon the recording of an instrument in the public records of the County stating that Declarant has relinquished its right to elect a majority of the members of the Board of Directors. In the event that subsequent changes to applicable Florida law pertaining to the transfer of control of the Master Association directly conflicts with the transfer of the control provisions as expressly set forth herein, the provisions of this section shall control except to the extent and only if Florida law legislatively mandates that the legislative changes to the transfer of control provisions be applied retroactively to provisions in effect as of the effective date of the legislation and then only to the limited extent as reasonably determined by Declarant necessary to accommodate the legislative changes pertaining to the transfer of control.
- D. Notwithstanding anything herein to the contrary, if at any time or times subsequent to any such transfer of control, Additional Property or further real property is added by the Declarant pursuant to Article V of the Declaration, such Additional Property or further real property shall automatically be and become Class B Units, Planned Units or Parcels, as appropriate. In addition, if following such addition of land, the total votes allocable to all Units, Planned Units or Parcels then owned by the Declarant (calculated as if all such Units, Planned Units or Parcels are Class B, whether or not they are) shall exceed the remaining total votes outstanding in the remaining Class A membership (i.e., excluding the Declarant), then any Class A Units, Planned Units or Parcels, owned by the Declarant shall automatically be reconverted to Class B.
- E. Declarant shall be entitled to elect at least one member of the Board as long as Declarant holds for sale in the ordinary course of business at least 5% of the real property constituting the Property that will ultimately be operated by the Master Association. After Declarant relinquishes control of the Master Association, Declarant may exercise the right to vote any Declarant-owned voting interests in the same manner as any other Member, except for purposes of reacquiring control of the Master Association or selecting the majority of the members of the Board of Directors.
- F. Upon transfer of control of the Master Association, Class B membership shall terminate and Declarant shall own portions of the Property in the same manner as a Class A Member.
- G. <u>Expansion of Voting Provisions</u>. The foregoing voting provisions may be expanded by provisions of the Declaration and of the By-Laws.

- shall be established by the recording in the public records of Escambia County, Florida, of a deed or other instrument establishing a transfer of record title to any Parcel for which membership has already been established as hereinabove provided, the Owner(s) designated by such instrument of convayance thereby becoming an Owner Member(s), and the prior Owner's membership thereby being terminated. In the event of death of an Owner Member, his membership shall be automatically transferred to his heirs or successors in interest. Notwithstanding the foregoing, the Association shall not be obligated to recognize such a transfer of membership until such time as the Association receives a true copy of the deed or other instrument establishing the transfer of ownership of said Parcel, and it shall be the responsibility and obligation of the former and new Owner of the Parcel to provide such true copy of said instrument to the Association.
- In the event any Parcel owned by an Owner Member is submitted to the jurisdiction of a Homeowners Association, the membership of the Owner Member associated with such Parcel shall automatically terminate upon the recording in the public records of Escambia County, Florida, of the deed restrictions or declaration submitting such Property to the jurisdiction of the Homeowners Association, and the Homeowners Association shall simultaneously become a Homeowners Association Member with respect to such Parcel. Notwithstanding the foregoing, the Master Association shall not be obligated to recognize such a transfer of membership until such time as the Master Association receives a true copy of the recorded declaration.
- 3. In the event a set of restrictions or a declaration submitting any Parcel to the jurisdiction of a Homeowners Association is terminated, the Homeowners Association's membership in the Master Association with respect to such Parcel shall automatically terminate upon the recording of such termination in the public records of Escambia County, Florida. The Owners of the Parcel formerly subject to the jurisdiction of the Homeowners Association shall collectively become one Owner Member of the Master Association antitled collectively to cast one (1) vote, unless and until the Parcel is again submitted to the jurisdiction of a Homeowners Association.
- 4. The share of a Member in the funds and assets of the Master Association cannot be assigned, hypothecated or transferred in any manner except as an appurtanance to the Parcel associated with the membership of the Member, nor may a membership be separately assigned, hypothecated or transferred in any manner except as an appurtanance to such Parcel.

### ARTICLE IV: TERM OF EXISTENCE

The Corporation shall have perpetual existence.

#### ARTICLE VI: MANAGEMENT

The affairs of the Corporation shall be managed by its Board of Directors, which shall consist of not less than 3 nor more than 9 individuals, the precise number to be fixed in the By-Laws or by the Board of Directors from time to time. Directors shall be elected for one year terms by the members at the annual members' meeting, to be held as scheduled by the Board of Directors in the manner prescribed in the By-Laws, and shall hold office until their respective auccessors are duly elected and qualified. Officers may be Directors. Officers and Directors do not need to be owners of Units or Parcels within the Property, and any individual who is an Officer, Director or Owner of any legal entity which is an Owner may serve as an Officer or Director. The Board shall elect a President, a Vice President, a Secretary, and a Treasurer of the Master Association, and such other officers as may, in the opinion of the Board, from time to time be necessary to adequately administer the effairs of the Master Association. Such officers are to hold office at the pleasure of the Board or until their successors are duly elected and qualified. Officers may be Directors. Any individual may hold 2 or more corporate offices, except that the offices of

President and Secretary may not be held by the same person. The officers shall have such duties as may be specified by the Board or the By-Laws of the Master Association. Vacancies occurring on the Board and among the officers shall be filled in the manner prescribed by the By-Laws of the Master Association.

Notwithstanding the foregoing, the Class B members shall have the right to elect all Directors as long as there shall be Class B membership, except that such Class B members, in their sole discretion, may voluntarily consent to the election of one director by the Class A members after 50% of the total number of Units which may be constructed on the Property have been conveyed to third parties.

#### ARTICLE VII; INITIAL OFFICERS

#### ARTIGLE IX: BY-LAWS

The By-Laws of the Master Association shall be adopted by the initial Board of Directors, as constituted under Article VIII above, at the organizational meeting of the Board. Thereafter the By-Laws may be altered, amended, or rescinded by the affirmative vote of 2/3 of the Board of Directors, and after notice to the members, by the majority vote of the members, present at any regular or special meeting of the membership. However, no amendment to the By-Laws shall be valid which affects any of the rights and privileges provided to Declarant without the written consent of Declarant as long as Declarant shall own any portion of the Property.

# ARTICLE X: AMENDMENTS

Amendments to these Articles of Incorporation shall be made in the following manner:

(a) The Board of Directors shall adopt a resolution setting forth a proposed amendment and, if members have been admitted, directing that it be submitted to a vote at a meeting of members, which may be either the annual or a special meeting. If no members have been admitted, the amendment shall be adopted by a vote of the majority of directors and the provisions for adoption by members shall not apply.

- Written notice setting forth the proposed amendment or a summary of the changes to be affected thereby shall be given to each member of record entitled to vote thereon within the time and in the manner provided by Florida Statutes for the giving of notice of meetings of members. If the meeting is an annual meeting, the proposed amendment or such summary may be included in the notice of such annual meeting.
- At such meeting, a vote of the members entitled to vote thereon shall be taken on the proposed amendment. The proposed amendment shall be adopted upon receiving the affirmative vote of a majority of the votes of all members entitled to vote thereon.

Any number of amendments may be submitted to the members and voted upon by them at one meeting.

Notwithstanding anything herein to the contrary, no amendment to these Articles of Incorporation shall be valid which affects any of the rights and privileges provided to Declarant without the written consent of Declarant as long as Declarant shall own any portion of the Property or Additional Property.

## ARTICLE XI: REGISTERED OFFICE AND AGENT

# ARTICLE XII: DISSOLUTION

The Master Association may be dissolved as provided by law. In the event of dissolution or final liquidation of the Master Association, the assets, both real and personal of the Master Association, shall be dedicated to an appropriate public agency or utility to be devoted to purposes as nearly as practicable to the same as those to which they were required to be devoted by the Master Association. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization, to be devoted to purposes as nearly as practicable to the same as those to which they were required to be devoted by the Association. No such disposition of Master Association properties shall be effective to divest or diminish any right or title of any Member vested under the Declaration unless made in accordance with the provisions of such Declaration. In addition to the foregoing, if at any time the sole member of the Master Association is a Homeowners Association, the Association may be dissolved at the election of the Homeowners Association, and in that event all of the assets, both real and personal, of the Association, shall be transferred and conveyed to such Homeowners Association.

In the event the Master Association is dissolved, the property consisting of the surface water management system shall be conveyed to an appropriate agency of local government, and that if not accepted, then the surface water management system shall be dedicated to a similar non-profit corporation.

# ARTICLE XIII: DEFINITIONS

Unless the context expressly requires otherwise, the terms used herein shall have the meanings set forth in the Declaration.
