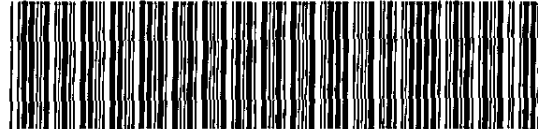

ARTICLES OF INCORPORATION
OF
FLORIDA FIRE PREVENTION ASSOCIATION, INC.
A Florida Corporation Not For Profit

The undersigned incorporator hereby incorporates this corporation as a Florida corporation not for profit under the Florida Not For Profit Corporation Act pursuant to the following articles of incorporation:

ARTICLE 1
NAME

The name of this corporation is Florida Fire Prevention Association, Inc.

ARTICLE 2
PRINCIPAL OFFICE

The street address of the principal office and mailing address of this corporation is 880 Airport Road, Suite 110, Ormond Beach, Florida 32174.

ARTICLE 3
PURPOSE

This corporation is organized as a business league pursuant to Section 501(c)(6) of the United States Internal Revenue Code. The general purposes for which this corporation is initially organized are to promote the common business interests of the members in enhancing public safety in the areas of fire prevention and control, and to engage in all types of lawful activity and forms of conduct which may be appropriate for the above described purposes and in which corporations not for profit may engage under Florida law, subject to the limitations and restrictions set forth in these articles.

ARTICLE 4
GENERAL POWERS

The corporation shall have the following general powers, subject to the limitations and restrictions set forth in these articles:

(a) All common law and statutory powers of a corporation not for profit not in conflict with the terms of these articles, including but not limited to all corporate powers enumerated in Chapter 617, Florida Statutes, and any successor statute.

(b) The power to perform all acts necessary for the accomplishment of the purposes for which the corporation is organized, to the extent that the same are not forbidden by these articles or the laws of the State of Florida.

**ARTICLE 5
LIMITATIONS**

The powers of this corporation and the exercise of such powers shall be subject to the following limitations and restrictions:

(a) No part of the net income of the corporation shall inure to the benefit of any private member or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, except as may be permissible under Section 501(c)(6) of the Internal Revenue Code, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(b) Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(6) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE 6
METHOD OF ELECTION OF DIRECTORS**

The method of election of directors shall be as stated in the bylaws.

**ARTICLE 7
QUALIFICATION AND ADMISSION OF MEMBERS**

The qualifications for members and the manner of their admission shall be as stated in the bylaws.

**ARTICLE 8
REGISTERED OFFICE; REGISTERED AGENT**
